- I have reviewed my bill and/or the course information and if I have any questions, I will ask them in advance of the course start, and that if there is any confusion it is up to me to seek clarification, that the course fee, materials costs and charter fees are non-refundable with less than 7 days' notice and must be paid in full regardless of course outcome or if I find that I cannot attend the class for any reason (i.e. Illness, personal problem etc.). I have also been advised that my accounts must be settled in full to receive certification.
- **IF I ARRIVE LATE or UNPREPARED or fail to complete my bookwork or the E-Learning and knowledge reviews prior to arrival**, that the course fee as well as other charges like charters, accommodation, travel, rental equipment or consumables maybe forfeit and **will not be refunded to me or the class rescheduled for me without charge.**
- That still images, and/or video and drone images of me may be taken during training and used as a training tool or could also be used for any purpose authorized by Rec & Tek SCUBA Inc., including but not limited to: Commercial use, website, social media and other online use, publications and advertising.
- I understand that it is my responsibility to either own or rent any equipment required for this course and that it is **not included** (unless noted on my bill) and that equipment must be suitable for the activity, as well as being regularly maintained and that if my instructor feels the equipment is unsafe, that I do not understand its operation or not appropriate for the activity, that they can deny my training.
- That completion of the course requires me to successfully demonstrate mastery of all required skills to the satisfaction of my instructor(s) in order to be certified. I understand that this is dependent on me and that my instructor is only able to assist, evaluate and guide me. If I am not successful, I may work with Rec & Tek SCUBA Inc. to arrange a makeup dive or dives at a later date at a cost of \$30 per dive plus any charter or rental fees if needed.
- That as I am a certified scuba diver or a student diver that I thoroughly understand the hazards of scuba diving including those hazards occurring during boat travel to and from the dive site (hereinafter collectively referred to as "Excursion"). I understand that these inherent risks include, but are not limited to, drowning, air expansion injuries, decompression sickness, embolism, or other hyperbaric injuries that require treatment in a recompression chamber; slipping or falling while on board, being cut or struck by a boat while in the water, injuries occurring while getting on or off a boat, and other perils of the sea; all of which can result in serious injury or death.
- I understand the Excursion will be conducted at a site that is remote, either by time or distance or both, from a recompression chamber and emergency medical facilities. I still choose to proceed with the Excursion. By signing this Agreement, I certify that I am fully aware of and expressly assume these and all other risks involved in making such a boat trip and scuba dive(s), whether conducted as a recreational dive or part of a diving class. I understand and agree that neither the divemaster/dive supervisor/instructor; nor the crew or owner of the vessel; nor the vessel itself, nor its affiliate or subsidiary corporations; nor the owners, officers, employees, agents, contractors or assigns of the above listed individuals and/or entities (hereinafter "Released Parties") may be held liable or responsible in any way for any personal injury, property damage, wrongful death or other damages to me or my family, estate, heirs or assigns that may occur as a result of my participation in this Excursion, or as a result of the negligence of any party, including the Released Parties, whether passive or active.

Finally, in signing this I understand that this is not a mere recitation but it is an agreement on what is required of me and what will be provided by Rec & Tek SCUBA Inc. for this program. I further release and hold harmless Rec & Tek SCUBA Inc., it's staff and owners from any lawsuit by me, my family, estate, heirs or assigns, arising out of my participation in this program including both claims arising during or after I receive my certification.
